CLASSIC VEHICLE SCHEME (CVS) RENEWALS

Things have changed, so please refer below.

Now that the Council of Motor Clubs (CMC) has become an approved organisation for Classic Vehicle Scheme (modified vehicles) registrations, MEG club members require the document - Classic Vehicle Declaration form 1835 to be stamped and signed from the CMC CVS and not the previously ACMC NSW Ltd club any longer.

The MEG member should fill in sections 1 and 2 of the Classic Vehicle Declaration (Transport for NSW form 1835).

Please don't fill in or sign Section 3 of that form. This is for the CMC CVS to fill in and sign by their authorised person as they are the MEG approved organisation.

The Primary Club i.e., MEG Club, stamps the lower right box only of 1835 to signify that the MEG member is a bona fide member of the Cronulla RSL MEG club and your vehicle is accepted by MEG. Without the MEG stamp the CMC CVS will not process the application. The stamp should be legible for all to read as Transport for NSW and Service NSW are strict on this requirement as photocopies or scan copies are not accepted.

Original CVS registration commencement where Transport NSW and Service NSW require an Unregistered Vehicle Inspection Report **Blue slip** must be obtained for the vehicle, no matter what registration the vehicle is currently on. This isn't the CMC CVS rule, it comes from Transport for NSW. For original CVS registration please don't send the original **Blue slip** to the CMC CVS as a photocopy is sufficient for their records along with the original 1835 form. If the vehicle is significantly modified it may need a Vehicle Safety Compliance (VSCC – Engineers Certificate refer to VSI 6 to be supplied on request).

Re-registering your vehicle on the CVS, please don't send the original **Pink Slip** to the CMC CVS as a photocopy is sufficient for their records along with the original 1835 form.

The fee is \$25.00 for the processing of **Original and Re-registering** a vehicle and included is a domestic letter tracking envelope for return to the MEG member.

The MEG member pays the \$25.00 fee by cheque, money order made payable to CMC CVS or you can EFT the funds to; **CMC CVS, BSB 633 000, Account 186322772** (changed name and numbers)

Please identify the payment in the reference field with a surname and initials. The postal address is **PO Box 174 Bexley NSW 2207** (changed PO Box).

On return of the paperwork from CMC CVS, take the original 1835 form and original Blue slip/Pink Slip to Service NSW Centre to complete the registration process. You will receive Conditional Registration Plates (for initial registration only), Certificate of Approved Operations, Registration paper work, Tax Invoice for CTP Green Slip and Log Book. These documents are to be kept in the vehicle when in use along with proof of current Primary Club membership receipt and proof of Club outing or completed Log Book entry.
